Choosing Your Qualification

Professional Qualifying Examinations (PQE)

The Professional Qualifying Examinations (PQE) forms the pinnacle of the ICS qualification. Completion of these exams is an illustration of one's developed knowledge and understanding of the commercial shipping industry. It comprises 7 exams which you can do over 5 years. Many people however complete in a much shorter time, and are often also eligible for exemptions to some exams based on industry experience and prior qualifications. Exemptions don't apply to the Diplomas, so if you are eligible for a few, it may make sense to start your journey with PQE.

Embarking on PQE will mean you need to sit a minimum of two exams in your first year (one of which must be Shipping Business), and can pick and choose how many to take thereafter from the syllabus. Once you have completed your PQEs you will be eligible to apply for membership with the Institute. ICS professional examinations represent the route to Chartered Status, allowing you to join ICS' international network of brokers, forwarders, agents, insurers, lawyers and other shipping service providers. Qualifications

Foundation Diploma

The Foundation Diploma is ideal for people with little industry experience, but who would like to gain practical knowledge and a sound qualification. It involves taking the **Introduction to Shipping** paper plus one other subject from the group 2 list of Optional Papers of the ICS syllabus. The Foundation Diploma is a standalone qualification in its own right, but because it can count towards your membership examinations it's also a great way to ease into study and gives you an overall view of the business. Foundation Diploma is awarded if both subjects are passed in the same exam sitting.

Advanced Diploma

The Advanced Diploma has been designed as a stepping stone into full professional qualification and suits those who have some industry knowledge. Like the Foundation Diploma, the Advanced Diploma is a recognised and respected qualification. It involves taking the ICS benchmark paper Shipping Business plus one other subject from the group 2 list of Optional Papers of the ICS syllabus. Advanced Diploma is awarded if both subjects are passed in the same exam sitting.

ICS Syllabus

The ICS syllabus for its Professional Qualifying Examinations (PQE) is designed to examine students on a wide range of commercial shipping activity.

Compulsory Papers - Group 1

These papers are compulsory because they represent the fundamental underpinnings of all activity within the commercial shipping industry. Shipping Business must be taken within your first year of study:-

- **Introduction to Shipping**
- **Economics of Sea Transport & International Trade**
- **Legal Principles in Shipping Business**
- **Shipping Business**

Optional Papers - Group 2

Optional papers cover a wide range of practical shipping disciplines in considerable detail:
